## **B. DOCUMENT REQUIREMENT**

The following documentation for import of exhibits into China is required for customs declaration and quarantine inspection. Originals should be attached to MAWB or send to LOXSON Logistics Shanghai office immediately prior to or on departure of shipment at origin. And copies must be provided via email or fax to LOSXON Logistics Shanghai office in accordance with the deadline listed.

#### **VERY IMPORTANT**

Please refer to the enclosed English/Chinese "List of Exhibits" form for Wine & Spirits. Value must be shown on your paperwork. Do not use NCV or NVD.

In addition, ORIGINAL Certificate of Origin and Health Certificate or analysis certificate is a must for the customs clearance and quarantine declaration on all wine & spirit& beverage, etc.

#### **ATTENTION**

All Chilled & Frozen products must be shipped by air on an individual Master Airway Bill direct to Shanghai Airport (PVG). The Airway Bill must state the storage temperature clearly in degrees Celsius.

- ☆ We shall NOT ACCEPT perishable cargo of different storage temperatures combined on one MAWB
- ☆ DO NOT mix dry, frozen or chilled food

## D. <u>TEMPORARY IMPORTATION</u>

The Chinese Authorities permit exhibits to be imported into China on temporary import basis on approved trade shows. Temporary import is allowed for 6 months from the date of entry and must be re-exported unless duties and taxes are paid in the event of conversion to permanent import. Extension of temporary import is allowed subject to Customs' approval.

## G. SAMPLES FOR QUARANTINE INSPECTION

Please ensure you pack separately from your exhibits and clearly mark the samples as 'for CIQ inspection".

Quantity of samples for CIQ inspection:

Less than 12 bottles/units per variety: 1 bottle per variety as testing sample 12-24 bottles/units per variety: 2 bottles per variety as testing sample

Over 24 bottles/units per variety: 10% based on total quantity

The separate package of testing samples will be extracted upon arrival at the exhibition venue. If not being packed separately, an on-site random pick will incur which may result in delay of delivery.

Any exhibitor failing to adhere to the above criteria risks the late arrival or even confiscation of their goods, for which LOSXON Logistics will not be held responsible.

#### H. CUSTOMS DUTIES

At the time of writing we expect customs to levy duties & tax on all wine imported for display at SIWC Shanghai China 2022. These duties are likely to exceed **50%** of the declared value and are non-refundable. If exhibitors set an unreasonably low value, customs reserve the right to set a basic rate across all commodities for the estimate duty and tax assessment. An estimated average duty and tax assessment for reference is as follows:

Wine (750ml) - RMB17.00/bottle

Spirit (whiskey, vodka, etc) - RMB76.00/750ml bottle or RMB8.00 per piece of miniature

Brandy (750ml) - RMB 115.00/bottle

Beer (standard can/bottle) - RMB2.40/can or bottle

Champagne/Sparkling Wine/Sake/Rice Wine/Ratefe (750ml) - RMB18.00/bottle

All duties will be prepaid on the exhibitors' behalf and be reimbursed by exhibitors before the opening of the show. Individual receipts is not available, as experience has shown that full commodity assessment will take place against only one official duty receipt for the entire show.

#### I. RESTRICTION

All exhibitors are advised that all promotional materials or giveaways to be imported for the exhibition must not

indicate or deem to indicate Tibet or Taiwan as a "Country".

#### J. PRINTED / PUBLICITY MATERIAL

The Ministry of Foreign Economic Relations and Trade in China stipulates that all advertising materials (like printed matters and giveaway items) and technical information materials in all media shall be allowed display or use at the exhibition only after customs has inspected and approved the censorship clearance.

Exhibitors are requested to submit samples of literatures (2 copies each) and souvenirs (2 each) in advance to LOSXON Logistics with a List of Exhibits (LOE). All these materials will be handed over to the Chinese Customs for inspection in advance. These materials should arrive at LOSXON Logistics no later than 45 days before show opening.

Films/slides/video tapes/ CDs, VCDs, DVDs are not allowed distributed & consumed during the show. For demonstration purpose, the censorship must be submitted 45 days prior the shipment arrival and 100% returned to the origin once the exhibition closed. LOSXON Logistics will not take any responsibility of the shipment detained/delayed due to lack of video products temporary import license.

In addition, exhibitors are advised that brochures, giveaways and souvenirs are subject to import duties as assessed by the Chinese Customs which must be payable on entry. The import of alcoholic drinks, cigarettes and foodstuff to exhibition are restricted by Chinese Customs.

## K. <u>HAND-CARRY EXHIBITS</u>

Exhibitors are strongly advised not to hand-carry goods for this exhibition as it could be detained by the Chinese Customs at the airport, Exhibitors should immediately hand over the detention receipt and the duly filled List of Exhibits to our staff at the fairground to load the goods from the airport. These exhibits will then have to be returned as a shipment.

The handling charges for the hand-carry items will be the same as our inbound airfreight charge, plus late arrival surcharges as applicable.

# L. LATE ARRIVAL

A late arrival surcharge of 30% based on basic handling ratewill be applicable if the shipment arrives after the stipulated deadline.

In the event of late arrivals, LOSXON Logistics will make allefforts to ensure delivery before the show opens; however, no guarantee can be given. The surcharge will apply regardless of delivery date to the show site. LOSXON Logistics also reserves the right to reject handling any cargo that arrives at the Shanghai seaport / airport only 7 days prior to the show open date. All additional charges incurred due to the late arrivals shall be borne by the exhibitors.

## M. PACKING OF EXHIBITS

Exhibitors shall be responsible for the consequences of improper packing

## **Protection against Damage and Rain**

As the exhibits are repeatedly loaded and unloaded during transportation, shocking/bumping will sometimes be inevitable. Moreover, exhibits will be placed outdoors many times, including open-air storage at the exhibition centre before and after the exhibition. Therefore, exhibitors must take necessary precautions against damage and rain, since we cannot assume any responsibility for the damage, especially when the return exhibits are to be packed with used-packing materials (the case as well as aluminium foil, plastic covers, etc., very often would have been damaged already during unpacking).

## Being strong enough for Transportation and Handling

The case must be strong enough to avoid damage during transportation as well as unpacking, and in particular, be suitable for repacking and for sale for return movement after the exhibition. Packing in cartons is not considered suitable for repeated handling, especially for valuable or delicate equipment.

## N. MOVE-IN DAYS

Exhibits will be transferred to the exhibition venue during the move-in days. Representatives of LOSXON Logistics will be available to help the exhibitors with the move-in logistics including unpacking and storage of empties as applicable. However, a responsible representative of the company must be available on-site during the move-in period for supervision. In some circumstances, however, the customs at the ports or fair site may inspect the case without your presence.

## O. MOVE-OUT DAYS

Prior to the move-out days, exhibitors will be given a 'Return Shipping Instructions' to fill in based on the List of Exhibts given at time of entry of goods into China. Exhibitors are required to advise LOSXON Logistics if the goods will be re-exported, sold or disposed, as applicable.

During move-out days, representatives of LOSXON Logistics will be on-site to help exhibitors with return of empty cases, repacking, re-export, etc. as applicable. Our on-site operational staff will inform exhibitors the exact arrangements.

In the event of non-compliance of return instructions, all goods left at the exhibition venue shall be subject to disposal by the Chinese Customs and all charges relating to the disposal including duties and taxes if any, shall be borne by the exhibitor.

Exhibitors must pay special attention to the following Customs' regulations:

- Items other than those declared exhibits (e.g. personal effects, souvenir bought in China) are absolutely not allowed to be returned together with exhibits.
- Violations of these regulations will result in confiscation and heavy fines imposed by the Chinese Customs.

PLEASE PAY ATTENTION THAT THE RAMAINING WINE/BEVERAGE/SPIRITS WHICH HAS NOT BEEN CONSUMED DURING THE SHOW WILL BE COLLECTED AND SUBMITTED TO CIQ AND CUSTOMS INSPECTION SITE FOR DESTROYING. IT'S FORBIDDEN TO GIVE AWAY THE REMAINING OF EXHIBITS AFTER THE SHOW CLOSED.

## P. RE-EXPORT

The re-export formality will require about 2 weeks prior to the re-export shipment out of China. If the exhibitor needs the goods to be re-exported urgently, please advise representatives of LOSXON Logistics on-site of your request as applicable.

## Q. SOLD GOODS / DISPOSAL

These wine are not allowed to sell by Customs now.

All goods sold or disposed or given away or not re-exported shall be subject to import duty and taxes of the CIF value or appraised value by Customs whichever is greater. The duty varies with commodities and the VAT is 17% of CIF value. The Procedures for Sold Goods are as follows:

- ☆Exhibitors are required to submit a copy of the contract, buyer's company name, address and contact number to LOSXON Logistics at the end of the show.
- ☆The buyer is required to present to Customs the invoice/packing list and sales contract for the processing of permanent import and payment of duty and taxes.
  - After the duties and taxes are paid, buyer will be allowed to take delivery of the goods from the Customs bonded warehouse.
  - For exhibits pending sale or waiting for signing of the sales contract, the exhibits will be transferred and kept in the Customs bonded warehouse subject to a maximum period of **SIX (6) MONTHS** from the date of import. After the period of six (6) months, the exhibits must either be re-exported or sold.

For sold exhibits, all duties and taxes must be paid and all import formalities must be completed within 6 months time. Failure to comply, cargo will be forfeited by the Customs. Sold goods pending conversion to permanent import shall be transferred to Customs bonded warehouse for storage. Additional charges shall be for account of the exhibitor unless assigned to the buyer.

## R. FUMIGATION RULES IN CHINA

Effective 1 January 2006, ALL CARGO WITH WOOD PACKING MATERIAL (WPM) to China (such as wood block cases, lath cases, wood pallets, wood frames, wood drums, wood axes, chocks, stow-wood, crossties and so on), fumigation must be arranged in the country of origin before sending the cargo to China,

To ensure the WPM is properly treated either by Heat Treatment (HT) or Methyl Bromide (MB), following information **MUST** be marked or stamped on the outside packing as the below sample:

- 1. IPPC Logo (
- 2. ISO country code (XX)
- 3. Unique number assigned to the company (which carries out the fumigation procedure) by the national plant protection organization (000)
- 4. Fumigation method either HT -Heat Treatment or MB Methyl Bromide (YY)

## S. CONTROLLED ITEMS CHINA

In case the shipment contains any controlled items by the Chinese Government, we strongly recommend that the list of exhibits should be faxed or e-mailed to LOSXON Logistics Shanghai Co., Ltd for checking prior to the shipment departure from the country of origin.

If required, LOSXON Logistics Shanghai Co., Ltd will apply necessary license/ permit on behalf of the exhibitors, but under no circumstances that LOSXON Logistics Shanghai Co., Ltd can guarantee such license will be granted.

If exhibitors need to ship any controlled items to China, exhibitors are required to submit to LOSXON Logistics the following documents/ information for application of import permit to China at least <u>45 days</u> prior to the shipment departure from the country of origin:

- a. Catalogue/ Brochure of commodities
- b. Export Permit Issued by the Products' Originating Country/ Place
- c. Certificate of origin and/or Health Certificate
- d. List of Exhibits

Relevant handling charge and guidelines, permit application fee in China for controlled items will be quoted upon request.

## T. INSURANCE

It is the responsibility of each exhibitor to arrange Marine (Transport) Insurance covering transport to the exhibition, during the exhibition, till the return of the exhibits to domicile/ exhibits sold locally, including the period the exhibits are handled by LOSXON Logistics Shanghai Co., Ltd. Our tariff is computed on the basis of volume and weight and has no correlation with the value of exhibits which means the cost of insurance cover is not included in our charges.

- 2. The above rates (for both seafreight and airfreight) exclude stand dressing, assembly of display panels or machinery or decoration of any kind. If these special services are required, it will be subject to a mutual agreement with the exhibitor and additional charges will be levied.
- 3. All Beverage and Foodstuff **MUST** be invoiced, packed & shipped separately from other exhibits & promotional materials. Failure to comply with the strict import requirements will cause unnecessary delays in clearance and may lead to confiscation and heavy additional expense being incurred.
- 4. Chilled & frozen storage will be made available under the supervision of the customs authorities upon Organizer's request. Rates will be quoted as per individual request in advance.

As the airlines implement strict security rules and will ask for magnetic detection & protection for many sensitive items by air transportation, we will bill magnetic detection & protection fee as per outlay if the detection and protection is incurred.

## F). STORAGE CHARGE AFTER CARGO ARRIVAL IN SHANGHAI

Inward storage starts from cargo arrival in Shanghai till first move-in date.

Outward storage starts from the last move-out date to the cargo dispatching at FCL/LCL or airport terminal warehouse before return.
